ORDER:-

In the reference 1<sup>st</sup> read above, orders were issued for constituting Affiliation Committee, regulating the fee structure and Affiliation procedure for Diploma in Elementary Education Course in Private D.El.Ed Colleges in superseding the earlier Affiliation procedure and fee structure.

2. In the reference 2<sup>nd</sup> read above, the Director, SCERT, A.P. Hyderabad has stated that the process of grant of affiliation every year is delaying the process of counselling and allotment of seats thereby causing abnormal delay in the commencement of academic year. Accordingly, the Director, SCERT has submitted a proposal to modify the procedure.

3. After careful examination of the matter and in supersession of the orders issued in the reference 1<sup>st</sup> read above, Government hereby issue the following order:

Affiliation Committee :

Director of School Education	- Chair Person
Director, SCERT	- Member Convenor
Director, Govt Examinations	- Member
One representative from the Universities concerned as suggested by APSCH	- Member
One Principal of Govt DIET as suggested by Director of School Education	- Member

4. The Affiliation for new Private DEI.Ed Institutions shall be initially for a period of one year and for granting of renewal of affiliation for the existing Private D.El.Ed Institutions for a period of four years and the following Affiliation Fee for D.El.Ed course is prescribed:

**Affiliation Fee for D.El.Ed course ( Private Elementary Training Institutions)**

i.	Affiliation Fee for 1 <sup>st</sup> year (fresh affiliation for an intake of 50 students)	: Rs. 75,000/-
ii.	Fee for renewal of affiliation for four years for the existing institutions	: Rs. 1,00,000/-

**Tuition Fee and Special Fee :**

- i. Tuition Fee Rs. 11,000/- per annum per candidate
- ii. Special Fee Rs. 1500/- per annum per candidate

5. The affiliation fee shall be remitted through D.D. or Banker Cheque drawn on any Nationalized Bank and shall be in favour of the Chairperson of the Affiliation Committee and the Director of School Education, A.P. Hyderabad.

6. The Management shall submit the proposals for affiliation alongwith affiliation fee to the Member Convenor who in turn shall verify to ensure that the conditions of recognition and affiliation are fulfilled by the management and place the proposals before the Affiliation Committee for scrutiny.

7. The Commissioner and Director of School Education, A.P. Hyderabad shall institute online procedure for obtaining the applications for affiliation and the required documentary proof from the managements for placing before the Affiliation Committee for scrutiny.

8. The Affiliation Committee shall be the authority to report the deviations if any, noticed with respect to the functioning of institutions, to the Government with a recommendation to limit the period of affiliation to the Institution/ for withdrawal of affiliation and to SRC, NCTE, Bangalore for withdrawal of recognition at any point of time after giving an opportunity to the management.

9. After thorough scrutiny of the proposals, the affiliation committee shall submit its recommendation in respect of each college to Government for its approval after which affiliation orders will be issued by the Director of School Education, A.P. Hyderabad.

10. The above orders come into effect from the academic year 2014-15.

11. The Commissioner and Director of School Education, A.P. Hyderabad/the Director, SCERT, A.P. Hyderabad is requested to take appropriate action in the matter immediately.
